



## SunSource Energy Named a Finalist for the 26th Annual Platts Global Energy Awards

Finalists represent 33 different countries from Europe, Asia, and the Americas

**New Delhi, India, October 8, 2024 –** SunSource Energy, a leading provider of solar energy solutions and a subsidiary of SHV Energy, a 127-year-old Dutch Multinational, has been selected as a finalist for the Platts Global Energy Awards program, now in its 26th year.

The 2024 finalists, nearly 56% of which hail from outside of the United States, were just announced by program host S&P Global Commodity Insights, the leading independent provider of information, data, analysis and benchmark prices for the energy, petrochemicals, metals, shipping, commodities, and energy transition markets. The Platts Global Energy Awards recognize corporate and individual innovation, leadership, and exemplary performance in 19 categories spanning the entire energy and chemicals value chain.

SunSource Energy has been announced as one of the 12 finalists for the 'Infrastructure Project of the Year' award' for its clean energy transition project in Lakshadweep. Constructed by SunSource Energy for Solar Energy Corporation of India (SECI), the project boasts a combined solar capacity of 1.7 MW and a 1.4 MWh battery storage system and is one of the first on-grid solar projects with a cutting-edge Battery Energy Storage System (BESS) for island electrification in India.

On this occasion, Santanu Guha, CEO, SunSource Energy said, "We are delighted to be recognized as a finalist in the Platts Global Energy Awards. The Lakshadweep (Solar with Battery Storage) project is an innovative environmental stewardship initiative of national importance and represents a monumental step towards sustainable energy for the region."
